Overview

The West Virginia Institute For Spirituality is committed to the formation of competent supervisors in the specialized ministry of spiritual direction. Supervision is an essential component of any spiritual direction training program. Participation in a spiritual direction training program assists individuals in discerning their call to be a spiritual director. Participants receive 75 to 120 hours of individual and group supervision. With completion of the certificate program for spiritual direction, a minimum of three years of directing and receiving on-going supervision, a spiritual director can apply for a certificate in supervision and advanced training.

Pre-Requisites For Application

- ♣ All candidates are expected to be in spiritual direction
- ♣ Hold a certificate in spiritual direction training
- ♣ Have a minimum of three years experience in directing since being certified
- ♣ Have two letters of reference
- ♣ Complete application for certificate, available for interview with Executive Director

Purpose of Certification Program

The Certificate in Advanced Training and Supervision is designed for experienced spiritual directors. This program facilitates education, enrichment and hands-on experiences by providing:

- ♣ Personal growth and formation in the art of supervision
- ♣ Knowledge and reflection exercises on the models of supervision
- ♣ Improved communication skills within the context of the helping relationship
- ♣ Discernment of one's call to the ministry of supervision in spiritual direction
- ♣ Practicum and supervision in directing the Spiritual Exercises in a retreat setting

This program is available to laity, religious, and clergy of all faith traditions. It will consist of lectures, required reading, group process, theological reflection, integration, professional identity, ethics and individual supervision.

Candidates in the Certificate Program for Supervision and Advanced Study can reserve rooms in advance at The West Virginia Institute For Spirituality.
